ASQ Section 1302 Phil Shanline Scholarship



General Information

This scholarship is open to students who will be attending any post-secondary institution in pursuit of a Certificate, Diploma or Degree. **Applicants must be residents of the ASQ Section 1302 territory, or will be attending a learning institution in the ASQ Section 1302 territory.** To verify eligibility, enter the following URL address: <http://www.asq.org/sections/find.html>
Enter the zip code of your home address and of the address of the learning institution. If Nebraska Section 1302 is shown as the nearest section for either zip code, you are eligible for the scholarship.

A total of **five** scholarships will be awarded: **Two \$1000** based solely on responses to application essay questions and **three \$1000** based on a combination of essay responses and financial need. All Scholarship winners will also receive a one-year student membership to the American Society for Quality.

The funds may be utilized for any expense allowable by the institution to which the checks are sent including tuition, fees, housing, books and other supplies necessary for completion of the recipient's program.

Scholarships will be awarded for the Academic year beginning in August and ending the following August.

Applicants must possess an overall grade point average of at least 2.0 for at least two periods at the last secondary or post-secondary institution which they attended.

Application (hard copy preferred) must be received by Section 1302 by March 15th of the current year for award pertinent to the Academic year beginning the following August. Award ceremonies will be held in May and actual checks mailed to institutions no later than September 10th. Depending on constraints of individual institution, an August mailing may be arranged. **NOTE: It is the responsibility of the applicant to furnish the name and address of the correct educational institution. Failure to do so may result in loss of the scholarship.**

Recipients should attend the award ceremony if at all possible. The awards ceremony is usually the third Thursday in May. Awardees will be contacted with details.

Applicants must provide supplementary information if requested. This may include verification of financial status.

NOTE: Submitted Applications and Essays become the property of ASQ-section 1302. Excerpts can be used in Newsletters, and to promote the Section, organization and/or the scholarship.

Instructions

1. All applications must be received by March 15th of the current year. A hard copy is preferred, but a soft copy (e-mail) is also acceptable. Resolution quality of a soft copy is the responsibility of the sender. Unreadable documents will not be accepted. All applications must include a formal transcript from the applicants last secondary or post-secondary institution.
2. The Scholarship application period will be from January 1st of the calendar year through March 15th.
3. Scholarship applications should be typed. Data will be accepted if hand written, but essay responses **MUST** be typed. Single Spaced, 12 point font size and Times New Roman, or Arial are preferred format.
